Dear Interest Owner:

Please be advised that as of March 20, 2023, Chesapeake Operating, LLC transferred its operatorship in oil and gas wells within the Brazos Valley Region to WildFire Energy Operating, LLC (“WildFire”). Consequently, WildFire will begin disbursing working and/or royalty interest revenues to you this June and thereafter between the 25th and 30th day of each month. The details concerning each disbursement will be made available to you through EnergyLink.

EnergyLink is a 24-hour, secure website you may visit to receive check details and tax forms related to your disbursements. To create a free EnergyLink account, please visit [www.energylink.com](http://www.energylink.com), select “Sign Up” at the top of the page, and follow the website’s instructions.

Additionally, to ensure WildFire’s records are up to date, we kindly ask you to execute and return the included *IRS Form W-9*. In the event you wish to receive revenue disbursements via an electronic funds transfer directly to a bank account, please complete the included *ACH Enrollment Form*, attach a voided check, and mail all documents to WildFire at the following address:
